An article submitted to Scientific Issues of Jan Długosz University in Częstochowa is first considered by the Scientific Board. If the subject of a paper is not consistent with the journal profile or the text of a paper contains distinct defects, a paper can be rejected.

After preliminary acceptance by the Scientific Board an article is sent to reviewers. The choice of reviewers is confidential. A review evaluates an article and indicates unambiguously whether or not an article can be published. After positive review, an author (authors) should correct an article according to suggestions of reviewers and submit to the Journal the final version of an article. The Scientific Board reserves the right for making small corrections in the text of the final version of an article.

If a paper is financed by some associations or other institutions, the indication of the source of finance is expected.

Submission of a paper for publication in Scientific Issues of Jan Długosz University in Częstochowa implies the acceptance of the following requirements.

- A person submitting an article is responsible for its contents.
- The Journal publishes only new and original research.
- Articles are published in paper and electronic versions. Paper version is the primary one.
- Publication in the Journal foresees no author's emoluments.
